

Sink & Surface Cleaner Sanitizer

Frequently Asked Questions

What is Sink & Surface Cleaner Sanitizer?

Sink & Surface Cleaner Sanitizer is designed for use as a third-sink sanitizer as well as for cleaning and sanitizing hard, non-porous food-contact surfaces in a variety of applications in foodservice environments. Sink & Surface Cleaner Sanitizer is registered as a cleaner and sanitizer for use on hard, non-porous food-contact surfaces under EPA Registration Number 1677-260.

Is the product effective against COVID-19?

Yes, see the EPA N-list.

Are there any precautions to consider?

Yes, being an acid-based product, it should not be mixed with chlorine.

Can Sink & Surface Cleaner Sanitizer (S&S Sanitizer) replace manual detergent? No, the amount of surfactants is not appropriate to remove that type of dirt.

Can Sink & Surface Cleaner Sanitizer replace a multipurpose cleaner?

Yes, it can be used as a cleaner on various surfaces. However, a specialized cleaner is required for heavy dirt or glass cleaning.

Can Sink & Surface Cleaner Sanitizer replace a bathroom cleaner?

No, Sink & Surface Cleaner Sanitizer is not designed for use in a bathroom application.

What are the active ingredients?

Dodecylbenzenesulfonic Acid (DDBSA, 272 – 700 ppm) and Lactic Acid (704 – 1875 ppm)

Is it safe for all types of surfaces?

It is **not** recommended to use on sensitive surfaces such as brass and marble.

How is the concentration tested?

Specific test strips are needed to measure DDBSA in conjunction with Lactic Acid. Quaternary or AFVT test strips do **not** work for the Sink & Surface Cleaner Sanitizer.

Are S&S ingredients approved for food contact surface disinfection?

Yes, all ingredients have been approved by the EPA according to 40 CFR 180.940 (a) for use in surface disinfectant solutions in contact with food. S&S also complies with the U.S. FDA Food Code (Versions 1997-2017, sections 4-501.114, 4-501.115, 4-603.16, and 7-204.11) when used according to product label instructions.

Why is this product listed as "S&S Sanitizer" in EPA List N?

Sink & Surface Cleaner Sanitizer (EPA Reg. No. 1677-260) is also known as S&S Sanitizer under the same record.

Is S&S a hospital grade disinfectant?

S&S is approved as a hospital disinfectant at dilution from 1.37 to 1.41 oz/gal when used in accordance with product use instructions. At this concentration, rinsing is required on food contact surfaces.

Is Personal Protective Equipment (PPE) required to apply S&S?

When used at the correct dilution, PPE is not required.
